- 2) Lakeshore Little League will distribute a copy of this Safety Manual to all **Managers/Coaches, League Volunteers, and the District Administrator**

- 4) Lakeshore Little League uses **J.D. Palentine (JDP)** to screen all our volunteers. Lakeshore uses the JDP QuickApp.
- 5) Fundamentals Training (**Coaches Clinic**): Scheduled for somewhere in the middle to late **April**.
- 6) Coaches will be required to **walk/inspect** the fields prior to practices and games. Umpires will also be required to walk the fields for **hazards** before each game.
- 7) Lakeshore Little League will complete and update our **2025 Facility Survey** online by late April.
- 8) Concession Stand Safety. ***Lakeshore Little League does not currently have concession stands at any field locations.***



- 9) The League Safety Officer will **inspect all equipment** in the pre-season.
- 10) **Managers/Coaches** will inspect equipment **prior to each game**.
- 11) **Umpires** will be required to inspect equipment prior to each game.
- 12) **Implement Prompt Accident Reporting**: The League will use the provided incident tracking form from the Little League website and **will provide completed Accident forms to Safety Officer within 24-48 hours of the incident**.
- 13) Each Team will be issued an **updated First Aid Kit** and it is a **requirement** to have it at every practice and game.



14) There is an **AED (Automated External Defibrillator)** located near the ball wall in Austin Park, Skaneateles, NY. There is also one located on the pavilion in Austin Park. Falls field also has an AED present.

15) **Lakeshore Little League will require ALL TEAMS to enforce Little League Rules Including:**

- *Proper Equipment for catchers.*
- *No on-deck batters outside of fence*
- *Coaches will not warm up pitchers*
- *Bases will disengage on all fields*

16) League Player Registration Data or Player Roster Data and Coach and Manager Data **must be submitted via the Little League Data Center at www.LittleLeague.org.**



17) First Aid Training: Will be scheduled in April for coaches.

Lakeshore Little League will require at least one manager/coach from each team to attend a First Aid Course once every 2 years. This training will be provided by the Skaneateles Ambulance Volunteer Emergency Service, Inc. (SAVES) and take place at 77 Fennell Street, Skaneateles NY.

(CPR or First Aid training obtained outside of the above course will be accepted if verification is provided by the manager/coach.)

18) Concussion training is **required for all volunteers at www.cdc.gov/headsup/youthsports/training/index.html. Records will be kept by the Safety Officer.**



19) SafeSport Act: All volunteers of Lakeshore Little League are **mandated reporters of suspected child abuse** (physical or sexual) and neglect within 24 hours. Volunteers are also to limit one-on-one contact with minors. Reports of abuse are to be made to the New York State Child Abuse Hotline: **(800) 342-3720**.

20) The “Abuse Awareness for Adults” training is **required for all volunteers** at www.usabdevelops.com. **Records will be kept by the Safety Officer.**
